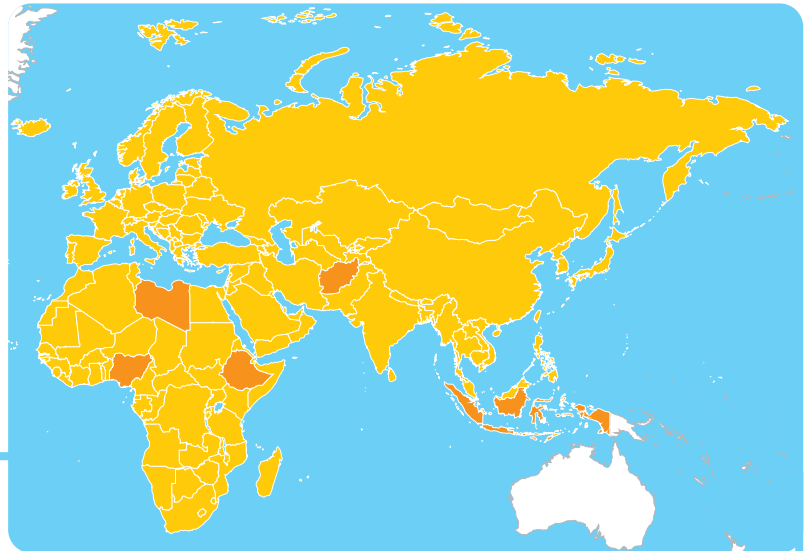
Specializing in timely data collection and analysis with hard to reach groups from Nangarhar to Tripoli.
